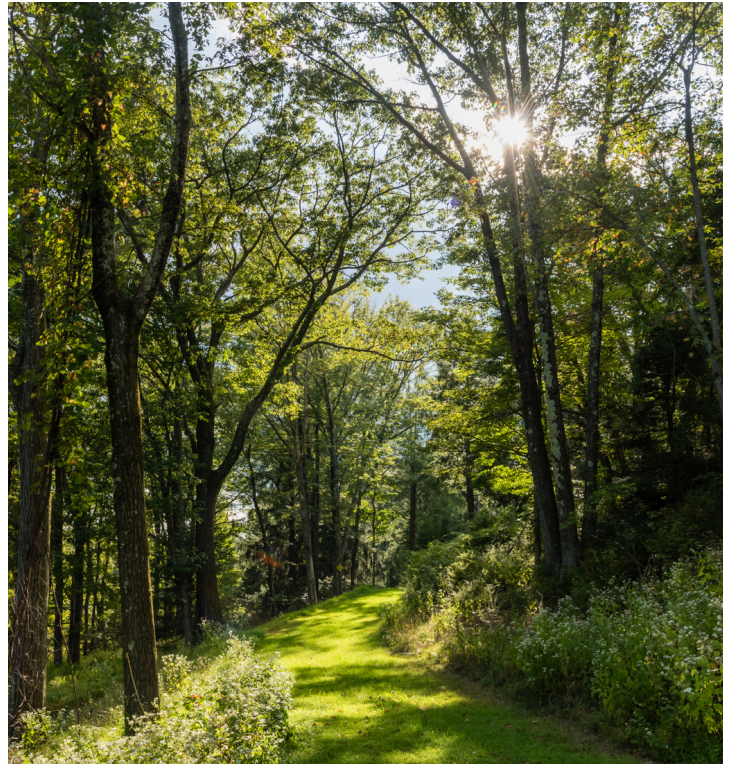
LEND YOUR LAND: JOIN THE CARBON FOREST PROJECT
